## I. INTRODUCTION

Based on the review of the quality, safety and efficacy data, the Member States have granted a marketing authorisation for Entecavir Alvogen 0.5 mg and 1 mg film-coated tablets from Alvogen Malta Operations (ROW) Ltd.

The product is indicated for the treatment of chronic hepatitis B virus (HBV) infection in adults with:

- compensated liver disease and evidence of active viral replication, persistently elevated serum alanine aminotransferase (ALT) levels and histological evidence of active inflammation and/or fibrosis
- decompensated liver disease

For both compensated and decompensated liver disease, this indication is based on clinical trial data in nucleoside naive patients with HBeAg positive and HBeAg negative HBV infection.

### Paediatric population

Treatment of chronic HBV infection in nucleoside naive paediatric patients from 2 to 18 years of age with compensated liver disease who have evidence of active viral replication and persistently elevated serum ALT levels, or histological evidence of moderate to severe inflammation and/or fibrosis.

A comprehensive description of the indications and posology is given in the SmPC.

This decentralised procedure concerns a generic application claiming essential similarity with the innovator product Baraclude 0.5 mg and 1 mg, film-coated tablets which has been registered in the EEA by Bristol-Myers Squibb Pharma EEIG through centralised procedure (EU/1/06/343/001-007) since 26 June 2006.

The concerned member states (CMS) involved in this procedure were Bulgaria, Hungary, Poland and Romania.

The marketing authorisation has been granted pursuant to Article 10(1) of Directive 2001/83/EC.

## II. QUALITY ASPECTS

### II.1 Introduction

Entecavir Alvogen is a film-coated tablet:

The 0.5 mg strength is a white oval shaped tablet with break line on both sides.

The 1 mg strength is a pink oval shaped tablet with break line on both sides.

Each tablet contains as active substance 0.5 mg or 1 mg entecavir, as monohydrate.

The film-coated tablets are packed in OPA-Alu-PVC/Alu perforated unit dose blisters.

The excipients are:

*Tablet core* - microcrystalline cellulose (E460), lactose monohydrate, pregelatinised maize starch, crospovidone (type A) (E1202) and magnesium stearate.

*Tablet coating* - titanium dioxide (E171), hypromellose (E464), macrogol 400 (E1521) and polysorbate 80 (E433). The 1 mg strength additionally contains red iron oxide (E172).

The two tablet strengths are dose proportional.

### II.2 Drug Substance

The active substance is entecavir monohydrate, an established active substance described in the European Pharmacopoeia (Ph.Eur.). Entecavir monohydrate is white to off white powder. It is practically insoluble in water, anhydrous ethanol and heptane and slightly soluble in methanol.

Entecavir monohydrate possesses three chiral centres. The Ph.Eur. monograph does report the existence of polymorphism (anhydrous and monohydrate). For the current application it is isolated in the monohydrate form.

The Active Substance Master File (ASMF) procedure is used for the active substance. The main objective of the ASMF procedure, commonly known as the European Drug Master File (EDMF) procedure, is to allow valuable confidential intellectual property or 'know-how' of the manufacturer of the active substance (ASM) to be protected, while at the same time allowing the applicant or marketing authorisation holder (MAH) to take full responsibility for the medicinal product, the quality and quality control of the active substance. Competent Authorities/EMA thus have access to the complete information that is necessary to evaluate the suitability of the use of the active substance in the medicinal product.

#### Manufacturing process

The manufacturing process consists of seven steps followed by recrystallization. The proposed starting materials are acceptable. The active substance has been adequately characterised and acceptable specifications have been adopted for the solvents and reagents.

#### Quality control of drug substance

The active substance specification is considered adequate to control the quality and meets the requirements of the monograph in the Ph.Eur. The MAH has adopted the specification of the ASMF-holder as drug substance specification, with an additional limit for particle size distribution, which was set experimentally. The proposed limits for particle size distribution are considered to be acceptable. Batch analytical data demonstrating compliance with the previous drug substance specification and has been provided for three batches of the active substance.

#### Stability of drug substance

Stability data of three batches have been provided in accordance with applicable European guidelines. The batches were stored at accelerated conditions (40°C/75% RH) for 6 months. The same batches as included in the accelerated studies were also included in the long term studies (25°C/60% RH) for 33 months. No trends are observed. Based on the provided stability data the proposed retest period of 36 months when stored under the stated conditions is accepted.

### **II.3 Medicinal Product**

#### Pharmaceutical development

The product is an established pharmaceutical form and its development is adequately described in accordance with the relevant European guidelines. The choice of excipients is justified and their functions are explained. The same excipients as in the reference product were selected, except for povidone which was replaced with pregelatinised starch for stability reasons. The main development studies performed were the characterisation of the reference product, Quality Target Product Profile (QTPP) of the drug product, excipient compatibility studies, prototype formulation and optimisation studies. Risk assessments have been performed at various stages. It has been demonstrated that the break line is functional and that the tablets can be divided into equal tablet halves of 0.25 mg and 0.5 mg. The provided additional justification is acceptable. Pharmaceutical development has been adequately performed.

A bioequivalence study has been performed with the 1 mg product strength. The provided dissolution profiles of the test and the reference product batches at three different pHs and in the medium proposed for routine dissolution testing (phosphate buffer pH 6.8), support bioequivalence. For the 0.5 mg product strength, a bio-waiver of strengths has been justified based on the results of *in vitro* dissolution studies (>85% in 15 minutes at three different pH levels).

#### Manufacturing process

The manufacturing process consists of premixture preparations, powder mixture preparation, (wet) granulation, drying, sieving, blending, compression, coating and packaging. The process is considered to be a non-standard manufacturing process. Process validation of the drug product has been presented for three full scale commercial batches of both strengths in accordance with the relevant European guidelines.

#### Control of excipients

With the exception of the two Opadry film coatings, all excipients comply with their respective Ph.Eur. monograph. For the Opadry film coatings, an in-house specification is included. These specifications are acceptable.

#### Quality control of drug product

The finished product specifications are adequate to control the relevant parameters for the dosage form. The specification includes tests appearance, identification, uniformity of dosage units, disintegration, dissolution, water content, related substances, assay and microbial quality. The proposed release and shelf-life specification tests and limits are acceptable. Limits in the specification have been justified and are considered appropriate for adequate quality control of the product.

Satisfactory validation data for the analytical methods have been provided. Batch analytical data from three commercial scale batches from the proposed production site have been provided, demonstrating compliance with the specification.

#### Stability of drug product

Stability data on the drug product has been provided for three full scale batches of each tablet strength. The drug product was stored for up to eighteen months at 25°C/60% RH and for up to eighteen months at 30°C/65% RH and for six months at 40°C/75% RH. The drug product was shown to be photostable, as no significant changes were observed in the tested parameters when the 0.5 mg tablets were directly exposed to UV and fluorescent light. The submitted stability data show only little changes over time in the obtained parameter results and normal analytical variability is observed.

On the basis of the available stability data, the proposed shelf-life of 24 months with the storage condition 'Do not store above 30°C. Store in the original package.' is granted.

#### Specific measures concerning the prevention of the transmission of animal spongiform encephalopathies

The drug substance and all excipients used other than lactose monohydrate are from non-animal and non-human origin. The excipient lactose monohydrate is safe with the view of possible TSE/BSE risk. Scientific data and/or certificates of suitability issued by the EDQM have been provided and compliance with the Note for Guidance on Minimising the Risk of Transmitting Animal Spongiform Encephalopathy Agents via medicinal products has been satisfactorily demonstrated.

### **II.4 Discussion on chemical, pharmaceutical and biological aspects**

Based on the submitted dossier, the member states consider that Entecavir Alvogen has a proven chemical-pharmaceutical quality. Sufficient controls have been laid down for the active substance and finished product.

No post-approval commitments were made.

## **III. NON-CLINICAL ASPECTS**

### **III.1 Ecotoxicity/environmental risk assessment (ERA)**

Since Entecavir Alvogen is intended for generic substitution, this will not lead to an increased exposure to the environment. An environmental risk assessment is therefore not deemed necessary.

### **III.2 Discussion on the non-clinical aspects**

This product is a generic formulation of Baraclude which is available on the European market. Reference is made to the preclinical data obtained with the innovator product. A non-clinical overview on the pharmacology, pharmacokinetics and toxicology has been provided, which is based on up-to-date and adequate scientific literature. The overview justifies why there is no need to generate additional non-clinical pharmacology, pharmacokinetics and toxicology data. Therefore, the member states agreed that no further non-clinical studies are required.

## IV. CLINICAL ASPECTS

### IV.1 Introduction

Entecavir monohydrate is a well-known active substance with established efficacy and tolerability. A clinical overview has been provided, which is based on scientific literature. The overview justifies why there is no need to generate additional clinical data. Therefore, the member states agreed that no further clinical studies are required.

For this generic application, the MAH has submitted one bioequivalence study, which is discussed below.

### IV.2 Pharmacokinetics

#### Bioequivalence study

The MAH conducted a bioequivalence study in which the pharmacokinetic profile of the test product Entecavir Alvogen 1 mg, film-coated tablets (Alvogen Malta Operations (ROW) Ltd, Malta) is compared with the pharmacokinetic profile of the reference product Baraclude 1 mg, film-coated tablets (Bristol-Myers Squibb GmbH & Co. KGaA, Germany).

#### *The choice of the reference product*

The choice of the reference product in the bioequivalence study has been justified.

The formula and preparation of the bioequivalence batch is identical to the formula proposed for marketing.

#### *Biowaiver*

The MAH was granted a biowaiver for the lower strength Entecavir Alvogen 0.5 mg film-coated tablets based on the following arguments:

- The qualitative and quantitative composition of the different strengths is dose proportional and only differs in the film coating, which is acceptable and in accordance with the guideline.
- Both strengths of Entecavir Alvogen are manufactured by the same process.
- Entecavir has linear pharmacokinetics over the therapeutic dose range.
- Both tablet strengths have comparable dissolution profiles according to the provided *in vitro* dissolution data.

#### *Design*

A single center, randomised, single dose, laboratory-blinded, two-period, two sequence, crossover bioequivalence study was carried out under fasted conditions in 26 healthy male and female subjects, aged 18-55 years. Each subject received a single dose (1 mg) of one of the two entecavir formulations. The tablet was orally administered with 240 ml water after an overnight fast of at least 10 hours. There were two dosing periods, separated by a washout period of 28 days.

Blood samples were collected pre-dose and at 0.17, 0.33, 0.5, 0.67, 0.83, 1.0, 1.25, 1.5, 1.75, 2.0, 3.0, 4.0, 6.0, 9.0, 12.0, 16.0, 24.0, 36.0, 48.0 and 72.0 hours after administration of the products.

The design of the study is acceptable and in accordance with the guideline on the investigation of bioequivalence and the product-specific guidance. The washout period is sufficient. The sample scheme covered a period of 72 hours is sufficient to estimate pharmacokinetic parameters of interest ( $C_{max}$  and  $AUC_{0-t}$ ). Also, the fasting conditions are in accordance with the product specific guidance.

#### *Analytical/statistical methods*

The analytical method has been adequately validated and is considered acceptable for analysis of the plasma samples. The methods used in this study for the pharmacokinetic calculations and statistical evaluation are considered acceptable.

#### *Results*

One subject did not complete the study. Therefore 25 subjects were eligible for pharmacokinetic analysis.

#### Conclusion on bioequivalence study

The 90% confidence intervals calculated for AUC<sub>0-t</sub> and C<sub>max</sub> are within the bioequivalence acceptance range of 0.80 – 1.25. Based on the submitted bioequivalence study Entecavir Alvogen is considered bioequivalent with Baraclude.

The MEB has been assured that the bioequivalence study has been conducted in accordance with acceptable standards of Good Clinical Practice (GCP, see Directive 2005/28/EC) and Good Laboratory Practice (GLP, see Directives 2004/9/EC and 2004/10/EC).

### **IV.3 Risk Management Plan**

The MAH has submitted a risk management plan, in accordance with the requirements of Directive 2001/83/EC as amended, describing the pharmacovigilance activities and interventions designed to identify, characterise, prevent or minimise risks relating to Entecavir Alvogen.

The member states agreed that routine pharmacovigilance activities and routine risk minimisation measures are sufficient for the risks and areas of missing information.

### **IV.4 Discussion on the clinical aspects**

For this authorisation, reference is made to the clinical studies and experience with the innovator product Baraclude. No new clinical studies were conducted. The MAH demonstrated through a bioequivalence study that the pharmacokinetic profile of the product is similar to the pharmacokinetic profile of this reference product. Risk management is adequately addressed. This generic medicinal product can be used instead of the reference product.

## **V. USER CONSULTATION**

The package leaflet has (PL) been evaluated via a user consultation study in accordance with the requirements of Articles 59(3) and 61(1) of Directive 2001/83/EC. The test consisted of: a pilot test, followed by two rounds with 10 participants each. The questions covered the following areas sufficiently: traceability, comprehensibility and applicability. The results show that the PL meets the criteria for readability as set out in the Guideline on the readability of the label and PL of medicinal products for human use.

## **VI. OVERALL CONCLUSION, BENEFIT/RISK ASSESSMENT AND RECOMMENDATION**

Entecavir Alvogen 0.5 mg and 1 mg film-coated tablets has a proven chemical-pharmaceutical quality and is a generic form of Baraclude 0.5 mg and 1 mg, film-coated tablets. Baraclude is a well-known medicinal product with an established favourable efficacy and safety profile.

Bioequivalence has been shown to be in compliance with the requirements of European guidance documents.

The Board followed the advice of the assessors.

There was no discussion in the CMD(h). Agreement between member states was reached during a written procedure. The member states, on the basis of the data submitted, considered that essential similarity has been demonstrated for Entecavir Alvogen with the reference product, and have therefore granted a marketing authorisation. The decentralised procedure was finalised with a positive outcome on 13 April 2017.
